## **Purchase Agreement**

AKC Boston Terrier Puppy D.O.B \_\_\_\_\_ Male\_\_\_\_ Female\_\_\_\_\_

This AKC Boston Terrier puppy is being sold for the price of \$\_\_\_\_\_\_ as "Pet Quality" with Limited Registration. A deposit in the amount of \$500.00 is required to hold the puppy of your choice. Deposits are non-refundable. The outstanding balance shall be paid in cash, Paypal or wire-transfer before the purchaser obtains possession of the puppy. All payments made through Paypal will be charged an additional fee of 4%. Final payments must be made 5 business days in advance of pick-up if using Paypal, Cash App, Venmo or Zelle. No personal checks, cashiers check or money orders are accepted as forms as payment. The breeder agrees to forward the AKC paperwork directly to the buyer once the balance is paid in full.

The Breeder agrees that the puppy has been found to be in good health, up to date on it's immunizations and dewormed. The Buyer (new owner) has 48 hours from the date of this agreement to have the puppy examined by a veterinarian of their own choice, If Possession occurs on the weekend or a Holiday, the Buyer shall have an additional 24 hours to have the puppy examined.

If the licensed veterinarian exam reveals that the Boston Terrier puppy has a life threatening genetic defect at the time of the exam, the Buyer must return the puppy within 2 weeks along with a written statement from the attending licensed veterinarian as to the health problem and have one (1) written report from an unassociated veterinarian stating the same problem. In addition, my personal veterinarian will also examine the puppy for their opinion. There are no refunds. Only then, the Breeder will provide a replacement puppy of comparable quality, color, sex and delivered at the buyers expense. There is no guarantee against accidents. The following are not considered "life threatening genetic defects". Cherry Eye, Hypoglycemia, Coccidia, Giardia and Kennel Cough, Fungal Infections, Parasites.In addition there is no guarantee against any communicable diseases such as Distemper, Parvo, Canine Influenza, and others i f not diagnosed within a 48 hour period. No veterinary bill will be paid by the Breeder.

Returning the Boston Terrier puppy will be at the buyer's own expense. If the Buyer chooses to keep the puppy, then no replacement will be given. After the 48 hours the Breeder has no warranties, either expressed or implied.

No replacement Puppy will be given if the puppy has been euthanized without the permission of the Breeder, before a consultation with the treating veterinarian. The exception to euthanasia would be in the case of severe injury or suffering on the part of the animal.

This dog is sold with limited registration and buyer agrees that this dog is to be spayed or neutered (unless otherwise noted). Registration will be held by seller until such time that buyer provides proof that this has been done (must be within 1 year). It is agreed that at no time will the owner sell or give this Boston Terrier to a pet store, a puppy mill operation, a dog pound, a dog broker or any similar enterprise or sell at auction. In the event the owner needs to rehome this Boston Terrier, the breeder will be contacted for assistance and offered the first right of refusal.
